## **Treasurers Report - Kim Hearst**

- Current bank balance as of 10/31/17 is \$30,700.00
- Membership dues are currently at \$4465.
- Actual from NESBA was \$8515 which exceeded budget due to high ticket sales.
- Proceeds from A Knight to Remember were \$5380.00 assuming all bidders pay their bill.
- Chorus uniform expenditures are half of what was budgeted.
- We currently have an excess of \$6300 in the budget due to successful fundraisers!
- > Treasurer's report was approved.

## **Band Director's Report - Justin Smalley**

- Justin contacted Stanford Uniforms who will have a representative come out after the new year to discuss uniform options. Will probably only include jackets and shako's since bib pants are universal and we purchased plumes this year.
- Justin would like to table the Macy's application until next fall. The plan would be to make a video during mid-October. The application would be submitted in March 2019 for a 2020 Thanksgiving Day performance.
- District auditions are Saturday 11/18. NAMA is running concessions.
- Winter Concert is 12/14 with the two band ensembles. It will be a shorter concert with a 10 minute intermission.
- Justin is considering dates for the Fall Banquet. This is challenging with multiple concert dates this year.

### **Chorus Director's Report - Sara Durkin**

- Winter concert will be 12/7 with 4 voice ensembles.
- Concert with the visiting conductor from Uruguay will be 1/18/18. This will also include a joint program with the English and Social Studies departments.

#### **Old Business:**

- Senior Recognition Night went fine for our group. Football and Cheerleaders were a bit disorganized. One suggestion was to have multiple photographers to speed things along.
- NESBA review included discussion from Jen Fiocchi and others on flow of the event, training and responsibilities of student volunteers, signage, and responsibilities of adult volunteers. Some students expressed frustration this year which will be addressed next year.
  - NESBA date for next year is key to success of the event. Would likely be 9/29 or 10/13.
  - o WPI has been invited next year.
- A Knight to Remember was well attended and enjoyable. The board agreed that we should do it again next year. Suggestions included a modest increase in price to allow higher food budget, no raffle, explore Saturday night option. The committee asked that board members continue to promote the event and always be thinking of successful auction item donations.

#### **New Business**

- Elaina Druid attended the meeting to discuss the growth of the color guard and her desire to begin fundraising to supplement purchase of uniforms and supplies for Fall 2018. Martin explained that the color guard is considered part of the Marching Band and uniform and supply needs for the Fall show should be submitted as part of the Marching Band Budget. Various ensembles typically do not do separate fundraising, and if we know budgetary needs ahead of time NAMA can add that to our fundraising efforts.
  - Elaina reported that they are recruiting 8<sup>th</sup> graders for Winter guard which will start in December and have a performance in April.
  - We will add Elaina to our distribution and we welcome director's reports from her.

- Santa Parade 11/25. Karen will get candy to distribute.
- NAMA presence at upcoming concerts will include the following:
